CONTINUING EDUCATION

Pursuant to NAC 634.385 it is the licensees responsibility to retain their continuing education certificates.

If you have renewed your license in previous years you are required to provide 36 hours of continuing education (may be attended online) attained from January 1, 2015 through December 31, 2016.

If you obtained your first license certificate during 2015 ~ 2016, continuing education hours are not required for the 2017/2018 renewal period.

The Board accepts all Providers of Approved Continuing Education (PACE) courses.

DISCIPLINARY ACTIONS

Mark Rubin, DC, License Number B648 Effective September 10, 2016

Dr. Rubin entered into a Settlement Agreement and Order with the Board on September 10, 2016, which orders his license to be on probation for three years. The matter stems from Dr. Rubin practicing chiropractic while collecting supplemental Security Disability and not properly reporting his income to the Social Security Administration.

Dr. Rubin admits to the First (Failure to Make, Maintain, and Provide Medical Records) and Second (Failure to Notify Patients of Lack of Malpractice Insurance) Causes of Action, and did not contest the Fourth (Making False Statement to Investigation) Cause of Action. Regarding the Third Cause of Action, Dr. Rubin did not

contest that his conduct may have constituted a violation of NRS 634.018 (10) as conduct unbecoming a chiropractic physician in that he did not notify SSD of his earnings as a chiropractic physician for the time period of March 2014 to March 2016.

Dr. Rubin's license shall be on probation for a period of three years effective September 10, 2016. Dr. Rubin shall provide documentation as noted in the Settlement Agreement and Order to the Investigating Board Member within the time frames identified.
