# CHANGES TO NRS AND NAC 634

Effective April 4, 2016 an amendment to NAC 634 was approved by the Legislative Commission. For the purposes of NRS 634.014, the Board interprets the term “precisely controlled force” to mean:

1. One or more thrusts involving both amplitude and velocity, including without limitation, one or more thrusts involving any combination of high or low amplitude and high or low velocity; or
2. An application of a resistive movement by applying a specific force, without the use of a thrust, to a specific focal point of the anatomy.

## 2015 Legislation

**Assembly Bill 231** was passed and became effective October 1, 2015.

**Section 1** authorizes the President, or designated member of the Board to require that a licensed chiropractic physician or chiropractor’s assistant submit to a mental or physical examination if their competence is questioned. This section also provides that the results of such an examination or of a diversion program for the treatment of alcohol or drug misuse by the person are not privileged.

**Section 2** expands the types of misleading public communications to include letterhead and electronic communications, such as social media and internet websites; and changes repeated malpractice as a grounds for discipline to any **single** incident of malpractice.

**Section 3** revises the requirements to include chiropractic training and education from certain foreign schools under certain circumstances.

**Section 4** waives the application fee for an applicant for a temporary license who applies for a temporary license for the sole purpose to provide chiropractic services to a patient in this State without remuneration.

**Section 5** revises the date by which the fee for renewal of a license or certificate must be paid. The language currently states...the renewal must be submitted to the Board on or before January 1. The language now states by January 1.

**Section 6** requires a licensee whose license has expired and who is applying to reinstate the license to submit a set of his or her fingerprints and pay a fee for the processing of the fingerprints.

**Assembly Bill 53** was passed and became effective July 1, 2015. This bill, among other revisions provides that the voluntary surrender of a license in a contested case will constitute disciplinary action against a licensee.

**Assembly Bill 89** was passed and became effective July 1, 2015. Requires a regulatory body to develop opportunities for reciprocity of licensure of active military, veterans, and surviving spouses of veterans if they hold valid license to practice his or her profession that is not recognized by this state.

# DISCIPLINARY ACTIONS

## **Timothy D. Francis, DC, License Number B309** **Effective August 20, 2015**

On August 20, 2015 Dr. Francis was found in violation of NRS 634.018(10), NRS 634.018(11), NRS 634.018(17), NRS 634.140(1), NAC 634.430(1)(a) and NAC 634.430(1)(o) engaging in a romantic relationship, while he was the treating chiropractic physician. Dr. Francis violated NRS 634.018(10), NRS 634.018(11), NRS 634.018(17), NRS 634.140(1) and NAC 634.435 failing to make or maintain any health care records regarding his diagnosis and treatment of his patient. Dr. Francis violated NAC 634.430(1)(a) and 2(c)(1) and 2(c)(2) by kissing his patient. Dr. Francis violated NAC 634.430(1)(a) and 2(c)(1) when he engaged in sexual relations with his patient. The Boards' charge, per NRS 634.019, is that the "practice of chiropractic is hereby declared to be a learned profession, affecting public safety and welfare and charged with the public interest, and therefore subject to protection and regulation by the State." The evidence showed that Dr. Francis did not keep his professional boundaries sharp and clean. The Board interprets and enforces NAC 634.430(1)(a) and 2(c) as intended to assure a sharp and clean professional boundary for a chiropractic physician. NAC 634.430(2)(c) makes clear, if a chiropractic physician and a patient find themselves in the midst of a mutual attraction, the chiropractic physician—as the professional in the budding relationship—must terminate the relationship.

Dr. Francis will be on probation for three years effective August 21, 2015. During the probation period Dr. Francis shall pay the costs incurred in the investigation and prosecution in the amount of \$60,484.16. Dr. Francis shall take and pass the Ethics and Boundaries Assessment Services (EBAS) Essay Examination and the Boards' jurisprudence exam within three months of the effective date of this order. Within one month from the date of the successful completion of the EBAS examination, Dr. Francis shall submit to the Investigating Board Member, a written correction plan addressing policies, procedures, and step he intends to take regarding teaching and chiropractic practices to assure that he maintains proper and distinct professional boundaries between his students, mentees, his personal friends, his partners, and his patients. The IBM will review and approve the correction plan. During the probation period the IBM, at his discretion, may speak to Dr. Francis to ensure he is following the approved correction plan.

## **Paul Rovetti, DC, License Number B328** **Effective April 7, 2016**

On April 7, 2016 Dr. Rovetti was found in violation of NRS 634.018(1) and/or 634.018(10) and/or NRS 634.0 and/or NRS 634.130(3), and/or 634.140(1) for not completing the requisite 36 hours of continuing education with his 2016-16 renewal and NRS 634.018(5) and/or NRS 634.018(10) and/or NRS 634.018(11) and/or NRS 634.018(12) and/or NRS 634.130(9) and/or NRS 634.140(1) and/or NAC 634.430(1)(n) by practicing chiropractic on patients

during a period in which his license was expired.

Dr. Rovetti's license as a chiropractic physician shall be suspended for a period of three months, but the suspension shall be stayed pending successful completion of the following terms and conditions of probation:

The term of probation shall be from the effective date of this Order until December 31, 2018. Dr. Rovetti shall take and pass the Board's jurisprudence examination and the Ethics and Boundaries examination within 90 days of the effective date of this Order. Dr. Rovetti shall provide written evidence of completion of at least 4.5 hours of continuing education every 90 days throughout the period of probation. Prior to the termination of the probation period Dr. Rovetti shall pay the Board's fees and costs of investigation and prosecution totaling \$1,718.90. Dr. Rovetti shall pay a fine totaling \$1,000.00.

## **Heriberto "Eddie" Soltero, PT** **Unlicensed Practice**

Effective December 8, 2015 Mr. Soltero was found in violation of NRS 634.227(2)(a) by practicing chiropractic in Nevada without a valid license issued by the Board.

Mr. Soltero will pay a fine of \$500 and reimburse the Boards' fee and costs incurred in the investigation and prosecution of this matter totaling \$2,295.00.
