## DC LICENSE RENEWALS ARE DUE BY DECEMBER 31, 2014

If you have renewed in previous years, you are required to submit documentation of your attendance at 36 hours of CPBN-approved continuing education during the period January 1, 2013 through December 31, 2014. Any or all 36 hours may be attended online. If you were first licensed in Nevada in 2013-14, continuing education hours are not required.

Continuing education documents may be faxed, mailed or e-mailed to the Board's office, or you may upload digital CE documents online using your personal dashboard account – accessible through the CPBN website: <http://chirobd.nv.gov/>.

There is an additional \$25 processing fee for renewing with the paper renewal form. You may pay with a check or call in your payment with a credit card. In addition to the child support and child abuse questions, the CPBN is now also required to collect Nevada Business License information from every licensee. If the form is not completely filled out it will be returned to you for completion, and your renewal will not be processed until we receive the completed form.
