LEGISLATIVE COMMITTEE**

A meeting of the CPBN Legislative Committee was held on Wednesday, March 16, 2011 by telephone conference call. A telephone was available for public use in Suite M245 at 4600 Kietzke Lane, Reno, Nevada 89502.

The following Committee Members were present at the roll call at 6:20 PM:

Also present were CPBN Secretary-Treasurer Ben Lurie, DC, Member Annette Zaro, DC, and Executive Director Cindy Wade.

Mr. Jackson determined that a quorum of the Committee was present and called the meeting to order.

**Agenda Item 1 Discussion/possible action regarding bill amendments in committee.**

Assembly Bill 215 was discussed at length. Mr. Jackson stated that 12 hours of continuing education for chiropractor's assistants is the national standard. The Board will need to make decisions regarding distance learning and face-to-face seminars and if the renewal years should be changed from the current even-numbered years for all licensees and certificate holders to even-numbered years for DC license renewals and CAs to odd-numbered years.

The NCA's preceptorship bill is not yet available but should be soon.

**Agenda Item 2 Discussion/possible action regarding bills on the floor.**

There are currently no bills on the floor that we need to watch.

**Agenda Item 3 Discussion/possible action regarding all relative bills.**

There is nothing new regarding AB 1 and AB 21.

Mr. Jackson moved to adjourn the meeting. Dr. Nolle seconded and the motion passed with both committee members in favor.
