Intent to Adopt Regulations

NOTICE IS HEREBY GIVEN that the Chiropractic Physicians' Board of Nevada will hold a public workshop to consider amendments to Nevada Administrative Code (NAC) 634. The workshop is scheduled to begin at **8:45 AM on Saturday, November 16, 2013 Meeting Room A of the Marriott's Courtyard, 3275 Paradise Road, Las Vegas, Nevada 89109.**

The workshop will be conducted in accordance with NRS 241.020, Nevada's Open Meeting Law.

The proposed additions/changes will revise Chapter 634 of the Nevada Administrative Code and will provide for:

NAC 634.xxx	New language to add provisions related to prepaid treatment plans.
NAC 634.xxx	New language to add provisions for interpretation of the phrase "conduct detrimental to the best interests of the public" as used in Subsection 10 of NRS 634.018 as applied to chiropractor's assistants.
NAC 634.xxx	New language to allow students enrolled in health care assistant programs to perform chiropractor's assistant services.
NAC 634.117	Amended definition of "Chiropractor's Assistant."
NAC 634.135	Increases in fees for: (1) An examination for a certificate as a chiropractor's assistant and (2) A review by the Board of a continuing education course.
NAC 634.220	Reducing the requirement from two to one fingerprint card that must be submitted by applicants.
NAC 634.290	Provision for open-book examination with a score of at least 90 percent.

NAC 634.330	Additional sanctions for cheating by applicants.
NAC 634.348	Establishment of certain parameters for taking and development of radiographs by chiropractor's assistants.
NAC 634.367	Authorization for issuance of a temporary licensee to a substitute for a licensee who is unable to practice due to military leave.
NAC 634.368	Deletion of the prohibition of performing chiropractic adjustments or manipulations by applicants waiting to take examination as required by statutory change to NRS 634.105.
NAC 634.373	Addition of requirement for registration of domain addresses.
NAC 634.385	Additional entities that may sponsor continuing education; and establishment of a limit of 12 to the number of hours of continuing education that may be attained online by licensees.
NAC 634.390	Addition of requirements for surrender of chiropractor's assistant certificates.
NAC 634.419	Deletion of massage therapy from the statement required from persons authorized to provide other services for patients in office of licensee.
NAC 634.435	Addition of requirement for notification to Board by licensees who close a practice of the location at which patients' records may be obtained.
