NOTICE OF INTENT TO ACT UPON A PROPOSED TEMPORARY REGULATION
T010-17

Notice of Hearing for the Adoption of a Temporary Regulation of the Chiropractic Physicians' Board of Nevada

Intent to Adopt Regulation

NOTICE IS HEREBY GIVEN that the Chiropractic Physicians' Board of Nevada will hold a public workshop to consider amendments to Nevada Administrative Code (NAC) 634. The workshop is scheduled to begin at **9:00 a.m. on Friday, July 14, 2017 at the Public Utilities Commission, Hearing Room B, 9075 W. Diablo Drive, Suite 250, Las Vegas, NV 89148 and Hearing Room B, 1150 E. William Street, Carson City, NV 89701.** The purpose of the hearing is to receive comments from all interested persons regarding the adoption of a regulation that pertains to Chapter 634 of the Nevada Administrative Code, LCB File No. T010-17.

The following information is provided pursuant to the requirements of NRS 233B.0603:

1. The need for and the purpose of the proposed regulation.

The purpose of the proposed regulation is to provide clarity and corrections to sections of NAC 634.

2. Either the terms or substance of the proposed regulation or a description of the subjects and issues involved.

NAC 634.290 Examinations required for licensure; passing score
NAC 634.320 Authorized persons in waiting area; conduct of applicant
NAC 634.305 Examination for certification as chiropractor's assistant
NRS 634.080 Licenses: Applications for examination
NRS 634.090 Licenses: Qualifications of applicants
NRS 634.115 Temporary license: Application; conditions; limitations.
NRS 634.131 Application for reinstatement of expired license; regulations

3. If the proposed regulation is a permanent regulation, a statement explaining how to obtain the approved or revised text of the proposed regulation prepared by the Legislative Counsel pursuant to NRS 233B.063.

4. A statement of the estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately and in each case must include:

- (a) Both adverse and beneficial effects.

There are no anticipated adverse or beneficial economic effects on the chiropractic profession or public.

- (b) Both immediate and long term effects.

There are no anticipated immediate or long term economic effects on the chiropractic profession or public.

5. A statement identifying the methods used by the Chiropractic Physicians' Board in determining the impact on a small business prepared pursuant to subsection 3 of NRS 233B.0608:

The Board has discussed the text of the various regulations at its meetings on April 21, 2017. The Board welcomed comments from persons attending the meeting, which always included at least one representative of at least one of the two organizations that represent Nevada's chiropractic physicians. At none of the discussions did any of the persons in attendance indicate that the regulations would have an adverse financial impact on small business. Additionally, most of the regulations effect the Board's licensing and testing procedures, and such regulations bear no new or additional fees and would and could not have any fiscal impact on the Board's licensees.

6. The estimated cost to the agency for enforcement of the proposed regulation.

There will be no significant cost to the Chiropractic Physicians' Board for enforcement of the proposed regulation.

7. A description of any regulations of other state or local government agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the regulation overlaps or duplicates a federal regulation, the notice must include the name of the regulating federal agency.

The Chiropractic Physicians' Board is not aware of any similar regulations of other state or government agencies that the proposed regulations overlap or duplicate.

8. If the regulation is required pursuant to federal law, a citation and description of the federal law.

This proposed regulation is not required by federal law.

9. If the regulation includes provisions which are more stringent than a federal regulation that regulates the same activity, a summary of such provisions

This proposed regulation does not include any provision that is more stringent than a federal regulation that regulates the same activity.

10. The time when, the place where and the manner in which interested persons may present their views regarding the proposed regulation.

Written submissions must be received by the Chiropractic Physicians' Board on or before July 7, 2017. If no person who is directly affected by the proposed action appears to request to make an oral presentation, the Chiropractic Physicians' Board may proceed immediately to act upon any written submission.

Upon adoption of any regulation, the agency, if requested to do so by an interested person either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
