INTRODUCTION

The Chiropractic Physicians' Board of Nevada was created in 1923. The Board enforces NRS and NAC chapters 634 which taken together authorize the Board to reasonably ensure that the citizens of Nevada receive competent chiropractic care from properly educated and licensed chiropractors. Without examination of basic knowledge and required continuing education throughout the careers of Nevada's chiropractors, Nevadans would be at risk of receiving substandard services.

Section 2, Subsection 1

The Board licenses chiropractic physicians and chiropractor's assistants. Pursuant to NAC 634.200 the board assesses the fees identified in the table below for entry into chiropractic.

Chiropractic physician applicants must have graduated from a chiropractic college accredited by the Council on Chiropractic Education (or in some unusual cases, a chiropractic college with which the CCE has a reciprocal agreement). There is a separate pathway that allows for foreign graduates to seek licensure in Nevada where the Board determines that their foreign schooling is equivalent to CCE standards. Chiropractic physician applicants must take and pass a four-part national examination administered by the National Board of Chiropractic Examiners. Additionally, chiropractic physicians must pass a Nevada jurisprudence examination administered by the Board. The examination has recently been moved to an online format as well as a paper format for the convenience of applicants.

Chiropractic assistant applicants must have completed formal training of at least twelve months of study or the equivalent of twelve months of on-the-job training with a Nevada chiropractic physician. Chiropractic assistant applicants must take a qualifications examination and a separate Nevada jurisprudence examination, both of which are administered by the Board twice per year in-person and three times per year on-line.

Chiropractic physicians renew their licenses every odd-numbered year, and chiropractic assistants renew their licensees every even-numbered year.

The Board is able to process an application by a chiropractic physician within no more than five days of receipt of the required documentation, however the current delay in the issuance of the license is the receipt of the background results from the Department of Public Safety, Records, Communications and Compliance Division. The current wait time is approximately six to eight weeks. Unfortunately, this means that Nevada's chiropractic physician applicants are unable to serve patients for six to eight weeks while they await the return of the background results.

Section 2, Subsection 2

Chiropractic Physicians are regulated in all 50 states, including Alaska and Canada.

Chiropractic assistants are regulated in fifteen states: Alaska, Arizona, Florida, Maine, Maryland, Massachusetts, Mississippi, Nevada, New Jersey, New Mexico, North Carolina, North Dakota, Oregon, South Dakota, and Tennessee.

Section 2, Subsection 3

The Board has already taken a number of important steps to lower barriers and expedite licensure of chiropractic physicians and chiropractic assistants, including setting up a useful licensure by reciprocity program, allowing older out-of-state chiropractic physicians to obtain licensure by only completing those portions of the NCBE examinations available at the time of their original licensure, and recognition of several foreign schools as satisfying Nevada's requirement. The Board is interested in and working with sister-states to create a nationwide licensing compact for chiropractic physicians, but that project is years away from operation. The Board has put its examinations online to facilitate easier access to applicants.

Prior to the regulation freeze ordered in Executive Order 2023-003, the Board was working on a regulation to allow the recognition of non-traditional high school graduations (such as charter schools, home schools, foreign schools, etc.) to suffice for chiropractic physician applicants, which regulation, if it had not been frozen, would have broadened the pool of potential applicants in Nevada. The Board has sought an exemption from the Governor's Office to allow it to proceed with this regulation.

Section 2, Subsection 4

Forty states, including Nevada, recognize some form of reciprocity or endorsement for chiropractic physicians. Nationwide, there is no reciprocity or endorsement for chiropractic assistants. The chiropractic profession does not currently have an approved interstate licensure compact; however, the Federation of Chiropractic Licensing Boards (FCLB) has previously applied

for a grant to create an interstate compact. This Board has expressed interest in being a part of the compact.

Section 3

Chiropractic physicians are licensed in all 50 states. Chiropractic assistants are licensed in fifteen states. Because the number of states that regulate chiropractic assistants does not meet the 26-state threshold set out in Executive Order 23-004 of 26 states, reluctantly the Board must inform the Governor that in order to remove chiropractic assistant licensure by July 1, 2023, the only available process would be for the Nevada Legislature to pass a bill removing all references to chiropractic assistants from the NRS, which the bill would then need to be signed by the Governor. Because chiropractic assistants are fully integrated into the practices of Nevada's chiropractic physicians statewide, and because chiropractic assistants extend the capabilities of Nevada's chiropractic physicians' abilities to serve as many Nevadans as possible, the Board asks that the Governor find that chiropractic assistants should not be presumed for removal, and the Board strongly urges the Governor not to seek the deregulation of chiropractic assistants.

Section 4

As previously stated, the chiropractic profession does not currently have an approved interstate licensure compact; however, the FCLB has previously applied for a grant to create an interstate compact. This Board has expressed interest in being a part of the compact. The Board does not anticipate that the FCLB compact for chiropractic physicians will be complete by July 1, 2023. The Board will participate in the FCLB process, and assuming the process ultimately produces a usable compact, the Board will take necessary actions – which might include Legislative or regulatory action – to participate in the compact once it exists.

NAC 634.363 permits License by Endorsement which allows an individual who has actively practiced chiropractic in another state for not fewer than seven of the ten years immediately preceding the date of submission of the application, who has no adverse disciplinary action taken against him or her, and who has completed requisite parts of the examination administered by the National Board of Chiropractic Examiners. For applicants who qualify for the endorsement process, licensure is processed as soon as all required documents are received. Forty states, including Nevada, recognize some form of reciprocity or endorsement for chiropractic physicians.
